### Parish Council Precept and Budget

At the Parish Council meeting on 9<sup>th</sup> January 2018 the Parish Council agreed a budget and precept of £5,292.00. This is an increase of £175 on the previous year's budget. The main reasons for this increase are an anticipated increased fee for the Internal Auditor, fees to appoint a Data Protection Officer and anticipated additional expenditure on the Neighbourhood Plan.

## Beast from the East

The recent weather conditions were challenging for all of us. A big Thank You to all those who supported their neighbours, enquired about people and gave help where required.

The recent conditions did not trigger the Emergency Plan but since the water shortage we were made aware that the Local Resilience Partnership could have received regular updates from Severn Trent.

We will be sure to utilise this in the future to keep the village informed.

### **Red Phone Kiosks**

Thieves have been touring many Leicestershire and Rutland villages trying to steal red telephone kiosks.

The thieves look official in high visibility clothing and claim to be from BT. In one village they arrived with a pneumatic drill and started to excavate the box.

A Ford Transit van reg no PK60 YVN with red and white stripes on the rear like a highways maintenance vehicle and a small white VW van reg no PK60 FVL with rear opaque windows were seen with the men.

Please be vigilant and if you see anything suspicious call 999.

### Local Bus Service

Leicestershire County Council (LCC) is consulting widely on the Leicestershire Passenger Transport Policy and Strategy (PTPS). The consultation period is from 21<sup>st</sup> March until 23<sup>rd</sup> June. This will look at how LCC can deliver value for money passenger transport services for Leicestershire having regard to their budget constraints.

The main likely impact of the proposed policy and strategy would be a reduction in the number of subsidised bus services. The present bus service for Tur Langton, service 44, is partially subsidised.

The consultation document classes this route as "Amber - Continuation at Risk". This is based on cost and performance in January 2018. Bus services are continually subject to operational or market changes so if the PTPS is adopted this classification may have changed by the time of review. If the outcome is that they will no longer subsidise service 44 the County Council will engage with local communities to consider alternatives. for example a demand responsive service and/or good neighbour or car sharing schemes. Changes to provision as a result of this review would not come into effect until the summer of 2019 at the earliest.

## **Emergency Response Plan**

The Parish Council is delighted to announce that it has adopted a Community Response Plan. The plan is designed to help organise support for our community in the event of an emergency.

As part of this scheme the Parish Council has been donated £600 worth of equipment for a Community Emergency Store, currently held by Cllr Bladon. The Crown Public House has been identified as the Emergency Centre should one be required. Many thanks to Trevor for his support in this.

### In the event of an emergency your first contact is 999

Make sure you are not in any danger. Gather as much information as you can about what has happened. When you call 999 they will ask you for details of what has happened, where, when and who is involved. Give YOUR contact details to the Emergency Services so they can call you back. Ring them again if the situation changes significantly.

Like yourself your neighbours may need reassuring that the emergency is being dealt with and that professional and skilled people are responding. In this situation what people need most is reliable, clear and concise information.

Our Community Emergency Plan identifies how we, as a community, can complement the emergency services in the event of an emergency. With that, if you feel you are aware of a community emergency, such as a localised flood, power cut, icy roads preventing use of certain walkways/roads, please call a member of the Parish Council and we will do our best to assist.

## **Grass Cutting**

The Parish Council has a Service Level Agreement with Leicestershire County Council for the cutting of the verges in the village between the 30 mph signs.

Our contract is with Leicestershire Gardens for 14 cuts between March and October. They charge £60 a cut and the we will receive reimbursement of £334.62 for the 2018 season from the County Council.

The map showing the areas for which the Parish Council has responsibility can be seen on the website by going to the "Local Information" tab and selecting "Grass Cutting". Alternatively the map can be obtained from the clerk. There is flexibility on the number and timing of cuts depending on weather conditions.

Cutting of grass on the roads between towns and villages (40 mph and above, classed as rural grass cutting routes) is the responsibility of Leicestershire County Council.

# **Roads Surface Dressing**

We are informed by Leics County Highways that a programme of surface dressing will take place from 23<sup>rd</sup> April to 31<sup>st</sup> August on the following local roads:

- Tur Langton, West Langton Road temporary 30 mph speed restriction
- Kibworth Harcourt, West Langton Road temporary prohibition of through traffic and temporary 30 mph speed restriction
- West Langton, West Langton Road temporary prohibition of through traffic and temporary 30 mph speed restriction
- Thorpe Langton, Back Lane and Church Lane temporary prohibition of through traffic
